Privacy Policy

This privacy policy sets out how Esentual uses and protects any information that you give Esentual when you use this website.

Esentual is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement. Esentual may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from 01/11/2011.

What we collect

We may collect the following information:

- name and job title
- contact information including address, email address, mobile number (if we request bank details it will be via a secure login to MyEsentual ONLY).
- demographic information such as postcode, preferences and interests
- pay or expense information entered into the "Calculator" will be used for "indicative calculations"
- timesheet, invoice, pay, income or expense information entered via the secure login of My Esentual is used for statutory calculations and must be accurate and where possible supported by physical information or evidence including but not limited to pay-slips, invoices, receipts, pension statements, interest statements, bank statements. Evidence is only required in the event that you have contracted Esentual's services that warrant supply of such information on your behalf e.g. tax calculations and for Self Assessment purposes.
- other information relevant to customer surveys and/or offers

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
- We may use the information to improve our products and services.
- We may periodically send promotional email about new products, special offers or other information which we think you may find interesting using the email address which you have provided.
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interests.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online. Where you are provided with a secure login to any Esentual facility, please keep this secure and do not divulge it to anyone else.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.
